PROCLAMATION NO. 234

RESERVING FOR NATIONAL PARK PURPOSES TO BE KNOWN AS THE "LUNETTA NATIONAL PARK" A CERTAIN PARCEL OF THE PRIVATE DOMAIN OF THE GOVERNMENT SITUATED IN THE DISTRICT OF ERMITA, CITY OF MANILA.

Upon the recommendation of the Secretary of Agriculture and Natural Resources as Chairman of the Commission of Parks and Wild Life, and pursuant to the provision of Section 64(e) of the Revised Administrative Code, I, RAMON MAGSAYSAY, President of the Philippines, do hereby withdraw from sale or settlement and reserve for National Park purposes to be known as the "Luneta National Park" under the administration of the Commission of Parks and Wild Life subject to private rights, if any there be, a certain parcel of the private domain of the Government, situated in the District of Ermita, City of Manila, provided, however, that such portions therein as form part of the road shall remain under the administration of the Commissioner of Public Highways, which parcel is more particularly described as follows:

"A PARCEL OF LAND (the proposed Luneta National Park), situated in the District of Ermita, City of Manila. Bounded on the N., by Remaining Portion of P. Burgos Drive, property of the Metropolitan Water District and Remaining Portion of Existing Street (No Name); on the E., by Remaining Portion of Existing Street (No Name); on the S., by Remaining Portion of Existing Street (No Name) and Remaining Portion of Calle San Luis; and on the W., by Property of the City Government of Manila. Beginning at a point marked "1" on the attached Sketch Plan of the proposed Luneta National Park,
